#### ***IAAER ACCA Central and Eastern European Emerging Accounting Scholars Research Workshop, held in conjunction with the AMIS 2018 International Conference***

The International Association for Accounting Education and Research (IAAER) and Association of Chartered Certified Accountants (ACCA) have hosted their annual Central and Eastern European Emerging Accounting Scholars Research Workshop in Bucharest, Romania on June 11-12, 2018. The workshop was held in conjunction with the AMIS 2018 International Conference organized by the Bucharest University of Economic Studies, Romania, Faculty of Accounting and Management Information Systems. 20 young researchers from the Czech Republic, Estonia, Poland, Romania and Turkey presented a total of eleven research papers and proposals. The received detailed feedback and advice from eight international, accomplished accounting academics from the United States, the United Kingdom, Switzerland, France, Germany and Norway. The networking events, supported by the local ACCA office in Bucharest, have allowed participants to interact with each other as well as with the international mentors enabling them to build research networks within and outside of Europe.
